New For 2023 NJSA Events

Effective January 1, 2023, all NJSA Junior Show purebred gilts, will exhibit by weight within month of birth. This method of exhibition was developed to exhibit gilts that have a measurable trait and keep birthdate as a show parameter.

The issue of over-aging purebred animals has been addressed as a serious concern for decades and has been identified as a



long-term threat to the sustainability of the NSR and purebred swine industry. The intent of the rule change is to correct what is, and has been, a serious problem in the industry. Without technology to accurately determine age and maturity of animals, the new policy's intent is to level the playing field for breeders and junior members alike. The Executive Committee believes that this new policy will allow animals of similar size to be compared and evaluated equally, without the advantage of age at NSR events. Weights, farrowing dates, and Weight per Day of Age (WDA) will be published in show catalogs and when appropriate, used as consideration for judges to make decisions. By Law & Constitution Changes

ARTICLE XIX - Markings and Identification Requirements, Section 1: Color Sentences 5-7 New language (effective January 1, 2023):

The ideal color pattern is black with six white points (face, four socks, tip of tail). Less desirable, but acceptable, are sandy colored hair in the areas where white and black border. Color Qualifications for Registration (boars, gilts and barrows must meet the following color requirements in order to be recorded): A Berkshire must have white on the face and tail, unless the tail is docked. Three of four legs must be white. A Berkshire must not have a spotted or mottling pattern, which is defined as an intermixture of black and white and/or red skin/hair anywhere on the pig's body (defined as anything above the elbow and flank and excludes the legs and under belly). Examples of spotted or mottling patterns include: cheetah and giraffe spotted markings anywhere on the back or side of the pig. Also, a Berkshire must not have a contiguous area of white and/or red skin/hair that exceeds 64 square inches anywhere on the body of a mature pig (approximately 8 x 8 square inch area on a 300 lb. pig; this would be equivalent to 11 square inches on a 50 lb pig). Finally, a Berkshire cannot have a full or 34 belting pattern that is defined as white skin or hair that fully encircles or nearly encircles the body anywhere between the base of the ear and base of the tail.

<u>By-laws Article XVIII – General Recording Requirements, Section 13</u>

New Language (proposed changes effective January 1, 2025):

All sires used to register Berkshire litters must be DNA banked and tested for the stress (HAL-1843) and Redement Napole (RN) genes. The sire's stress and Redement Napole results must be negative for litter registrations, however if the status of the boar is a negative mating and the boar does not test negative, we will follow the Standard Procedures for DNA Testing and Report of Results.

Constitution Article II – Section 2

New Language (addition of a 3rd sentence):

If a member has multiple accounts and has a past due balance greater than 120 days on any of their accounts, the member will lose voting rights on all accounts and will be ineligible to serve on the Board of Directors Keep an eye out when announcements are made for the 2023 Summer show schedule!
